Factors considered in making awards include the amount requested, Pell eligibility, extraordinary financial circumstances, loss of employment, reduced income, housing or food insecurity, marital status, number of children, and other information submitted or expressed to the Business Office, Student Development or Financial Aid Office. These factors were reviewed by a committee representing the Financial Aid, Student Development and Business Offices.

Emergency financial aid grants were provided to students with these instructions:

These <u>emergency financial aid grants</u> may be used by students for any component of your cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including

mental health care) or child care. Students, you determine how you may use these emergency financial aid grants within the allowable uses. By requesting these funds, you agreed that these funds will be used for, or are a reimbursement for, the above stated purposes.

These funds are not taxable to you. Each applicant either declined a grant or entered a dollar figure on the application. If you requested \$250 or less, you received the full amount of your request. Factors considered in making awards include the amount requested, Pell eligibility, extraordinary financial circumstances, loss of employment, reduced income, housing or food insecurity, marital status, number of children, and other information submitted or expressed to the Business Office, Student Development or Financial Aid Office.
