Kuyper College has signed and returned to the Department of Education the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

**For the April 2021 awards**, eligible students were invited by email to apply for emergency financial aid grants. Factors considered in making awards include the amount requested, Pell eligibility, extraordinary financial circumstances, loss of employment, reduced income, housing or food insecurity, marital status, number of children, and other information submitted or expressed to the Business Office, Student Development or Financial Aid Office. These factors were reviewed by a committee representing the Financial Aid, Student Development and Business Offices.

Emergency financial aid grants were provided to students with these instructions:

These emergency financial aid grants may be used by students for any component of your cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including

mental health care) or child care. Students, you determine how you may use these emergency financial aid grants within the allowable uses. By requesting these funds, you agreed that these funds will be used for, or are a reimbursement for, the above stated purposes.

These funds are not taxable to you. Each applicant either declined a grant or entered a dollar figure on the application. If you requested \$250 or less, you received the full amount of your request. Factors considered in making awards include the amount requested, Pell eligibility, extraordinary financial circumstances, loss of employment, reduced income, housing or food insecurity, marital status, number of children, and other information submitted or expressed to the Business Office, Student Development or Financial Aid Office.

**For the July 2021 awards**, an eligible student made a request for emergency housing assistance. The request was reviewed by a committee representing the Financial Aid, Student Development and Business Offices and was approved by the President.

**For the November 2021 awards**, every eligible student was notified in October 2021 of their eligibility, offered the opportunity to accept or reject the award, to apply the grant to their student account or receive a check, or make a request for additional financial assistance.

The requests for additional assistance were reviewed by a committee representing the Financial Aid, Student Development and Business Offices and was approved by the President. Instructions to the students were:

These funds are not taxable to you. Each student must either decline or accept the grant by October 28th, 2021.
