Canadian Financial Aid Guide 2024 – 2025

Kuyper College recognizes students' academic achievement and exceptional talents through a variety of renewable merit-based and endowed scholarships. Detailed information is provided below.

Kuyper Academic Scholarships

These renewable awards are based on academic merit (cumulative marks) and range from \$1,000 - \$8,000 per year. Kuyper Achievement Awards are awarded on a rolling basis soon after acceptance to the College.

Canadian Student Loan Program

Through the Canadian Student Loan Program, loans are provided to Canadian students through their province/territory even if the student attends a college outside of Canada. A student may obtain an application kit from their high school guidance counselor, a Canadian college or university, or the Student Awards Branch of the Ministry of College and Universities within their province/territory. Please read all instructions carefully because each province/territory follows its own procedures. Kuyper College's Financial Aid Office will need to fill out a portion of the loan application in order to confirm the amount requested, enrollment status, program of study and other information requested by the Canadian Government. Please turn your completed application in to the Financial Aid Office as soon as possible, as the loan may take up to 10 weeks to process.

KuyperWorks Program

KuyperWorks is an innovative program that integrates the learning from college workplace environments with academics to make a student ready for today's careers. The program's purpose is to contribute to the education of the whole person by facilitating institutionally significant opportunities for students to grow in character, work ethic, problem solving, critical thinking, responsibility, time management, leadership, and essential areas of professional competency while at the same time making a quality college education more affordable and accessible.

Dual Citizenship

If a Canadian student has citizenship in both the United States and Canada ("dual citizenship"), the student may apply for U.S. government financial aid by first completing the Free Application for Federal Student Aid (FAFSA). The FAFSA is available at www.fafsa.gov and will be processed through Kuyper's Financial Aid Office.
